I am pleased to invite you to the Annual General Meeting of Andrews Sykes Group plc (the "Company") for 2023 (the "2023 AGM").

The 2023 AGM will take place at Unit 5, Peninsular Park Road, London, SE7 7TZ at 3.00 p.m. on 14 June 2023.

Included in this document (on pages 4 to 5) is a Notice convening the 2023 AGM at the place, time and date stated above. This letter gives further information on the resolutions which will be proposed at the 2023 AGM (as set out in the Notice included in this document) and how shareholders of the Company can vote in respect of those resolutions.

Proxy voting

Whether or not you intend to attend the 2023 AGM, you are encouraged to vote by proxy at the 2023 AGM. This can be done in one of the following ways:-

- in the case of CREST members, by utilising the CREST electronic proxy appointment service in accordance with the procedures set out in note 3 to the Notice of AGM; or
- in the case of institutional investors, they may be able to appoint a proxy electronically via the Proxymity platform, a process which has been agreed by the Company and approved by the Registrar, in accordance with procedures set out in note 4 to the Notice of the 2023 AGM; or
- by completing the accompanying Form of Proxy (in accordance with note 2 to the Notice of 2023 AGM and the notes set out in the Form of Proxy itself) and lodging it with the Company's registrars, Equiniti Limited, Aspect House, Spencer Road, Lancing, West Sussex BN99 6DA.

To be valid, the proxy appointment must be received in accordance with the notes to the Notice of the 2023 AGM set out on pages 4 to 5 of this document by not later than 3.00 p.m. on 12 June 2023.

Resolutions to be proposed at the 2023 AGM

Turning then to the resolutions to be proposed at the 2023 AGM on 14 June 2023, these are as follows:-

Resolution 1 - to receive and adopt the 2022 Annual Report & Accounts

The Companies Act 2006 (the "**Companies Act**") requires the directors of a public company to lay its annual accounts and reports before the company in Annual General Meeting. Resolution 1 will therefore be proposed at the 2023 AGM, as an ordinary resolution, to receive and adopt the financial statements for the 12 months ended 31 December 2022, together with the strategic report, Directors' report and auditor's report (the "**2022 Annual Report & Accounts**"). Shareholders who have requested to be sent hard copies of documents sent out by the Company will find enclosed with this document a copy of the 2022 Annual Report & Accounts. The 2022 Annual Report & Accounts are in any event available on the Company's website at https://www.andrews-sykes.com/info/investor-information/#t5.

Resolutions 2 and 3 - to re-elect Xavier Mignolet and Marie-Claire Leon as Directors

In accordance with the requirements of article 93.1 of the Company's articles of association, and the Corporate Governance policy currently in force, Xavier Mignolet and Marie-Claire Leon retire as Directors at the 2023 AGM, but being eligible and wishing to serve again, offer themselves for re-election as Directors. Resolutions 2 and 3 will be proposed separately.

Information on Xavier Mignolet and Marie-Claire Leon can be found on page 24 of the 2022 Annual Report & Accounts.

Resolution 4 - to approve the payment of a final dividend for the 12 months ended 31 December 2022

A final dividend of 14.0 pence per Ordinary Share for the 12 months ended 31 December 2022 is recommended by the Directors for payment on 16 June 2023 to shareholders on the register of members of the Company as at the close of business on 26 May 2023 and resolution 4 is being proposed to obtain shareholder approval of such payment. This would involve a total dividend payment of £5.9 million.

Together with the interim dividend of 11.90 pence per Ordinary Share and the special dividend of 16.60 pence per Ordinary Share, both paid on 4 November 2022 to shareholders on the register of members as at 7 October 2022 and subject to shareholder approval of the final dividend, an aggregate dividend of 42.5 pence per Ordinary Shares will have been paid in respect of the 12 months ended 31 December 2022.

Resolution 5 - to re-appoint Mazars LLP as auditor and to authorise the Directors to fix the auditor's remuneration

Since the last Annual General Meeting of the Company held on 14 June 2022, Mazars LLP has been appointed by the board of directors of the Company as the Company's auditor. Resolution 5 is being proposed to obtain shareholder approval for the re-appointment of Mazars LLP as the Company's auditor and to authorise the Directors to fix the auditor's remuneration.

Resolution 6 - to give general authority to the Directors to allot shares

Under the Companies Act, the Directors may only allot shares (or grant certain rights over shares) with the authority of shareholders in General Meeting (other than pursuant to an employee share scheme). The Directors' existing authority to allot shares, which was granted at the Annual General Meeting of the Company held on 14 June 2022, will expire at the conclusion of the 2023 AGM.

Resolution 6 will be proposed, as an ordinary resolution, to authorise the Directors to allot Ordinary Shares up to a maximum nominal amount of £63,204 representing approximately 15 per cent. of the nominal value of the Ordinary Shares in issue on 2 May 2023 (being the last business day prior to the printing of the document). The Company does not currently hold any shares in treasury.

The authority conferred by Resolution 6 will expire at the end of next year's Annual General Meeting or, if sooner, on the date which is 15 months after the passing of this resolution.

The Directors have no current intention of exercising this authority. However, the Directors believe it to be in the best interests of the Company that they should continue to have this authority to maintain the flexibility that this authority provides.

Resolution 7 - to give power to the Directors to disapply pre-emption rights when allotting shares for cash

Unless they are given an appropriate authority by shareholders, if the Directors wish to allot any shares for cash or grant rights over shares or sell treasury shares for cash (other than pursuant to an employee share scheme), they must first offer them to existing shareholders in proportion to their existing holdings. These are known as 'statutory pre-emption rights'.

The existing disapplication of these statutory pre-emption rights, which was granted at the Annual General Meeting of the Company held on 14 June 2022, will expire at the conclusion of the 2023 AGM. Accordingly, Resolution 7 will be proposed as a special resolution, to give the Directors power to allot shares without the application of these statutory pre-emption rights and contains a two-part disapplication of the statutory pre-emption rights: first, in relation to allotments of shares for cash in connection with an offer by way of a rights issue or other pre-emptive issue, to allow the Directors to make appropriate exclusions and other arrangements to resolve legal or practical problems which, for example, might arise in relation to overseas shareholders; and second, in relation to the allotment of equity securities for cash up to a maximum aggregate nominal amount of £63,204 (representing approximately 15 per cent. of the nominal value of the Ordinary Shares in issue on 2 May 2023, being the last business day prior to the printing of the document).

The Directors are of the opinion that it would be advantageous for the Company to have the ability to issue ordinary shares on a non-preemptive basis in order to respond rapidly to opportunities that may occur, provided that such opportunities would benefit all of the Company's shareholders as a body. The Directors have no present intention of exercising the powers set out in Resolution 7. However, the powers give the Directors flexibility to take advantage of business opportunities that may arise.

The powers sought and limits set by Resolution 7 will also apply to a sale by the Company of any shares it holds as treasury shares. The Companies Act permits shares purchased by the Company out of distributable profits to be held as treasury shares, which may then be cancelled, sold for cash or used to meet the Company's obligations under its employee share-based incentive schemes.

The powers conferred by Resolution 7 will expire at the end of next year's Annual General Meeting or, if sooner, on the date which is 15 months after the passing of this resolution.

Resolution 8 - to authorise the Company to purchase its own shares

At the Annual General Meeting of the Company held on 14 June 2022, the Company was authorised to make market purchases of up to 5,271,794 of its own Ordinary Shares. As at 2 May 2023 (being the last business day prior to the printing of the document), such authority had been utilised to make market purchases of an aggregate 11,656 Ordinary Shares, all of which shares were cancelled immediately on purchase.

Resolution 8, which will be proposed as an ordinary resolution, will authorise the Company to make market purchases of up to 5,267,048 Ordinary Shares. This equals approximately 12.5 per cent of the Company's Ordinary Shares in issue on 2 May 2023 (being the last business day prior to the printing of the document). The maximum price that may be paid shall be the higher of (i) 5 per cent above the average of the middle market quotations for an Ordinary Share for the five business days immediately preceding the date of purchase and (ii) the higher of the price of the last independent trade and the highest current independent bid on the trading venue where the purchase is carried out at the relevant time (in each case exclusive of all expenses). The minimum price which may be paid for each Ordinary Share shall be the nominal value of any such shares (being 1 pence) (exclusive of all expenses).

The authority conferred by Resolution 8 will expire at the end of next year's Annual General Meeting or, if sooner, on the date which is 15 months after the passing of this resolution.

Seeking this authority from shareholders should not be taken to imply that shares will be purchased. The Directors believe it is in the best interests of all the shareholders that the Company should have the flexibility to make market purchases of its own shares. It is anticipated that any shares purchased by the Company would be immediately cancelled (and not held in treasury). The effect of such purchases and their cancellation would be to reduce the number of shares in issue and the Directors would accordingly only make such purchases after considering the effect on earnings per share and the benefit for shareholders of the Company.

Recommendation

The Directors of the Company consider that each of the resolutions set out in the notice of the 2023 AGM is in the best interests of the Company and its shareholders as a whole and unanimously recommend that shareholders vote in favour of each of the resolutions to be proposed at the 2023 AGM as they intend to do in respect of their own beneficial shareholdings of an aggregate 1,691,435 Ordinary Shares (representing approximately 4.01 per cent. of the Company's issued share capital).

1. Entitlement to attend, speak and vote at the meeting

To be entitled to attend and vote at the meeting (and for the purposes of the determination by the Company of the votes they may cast), members must be entered on the register of members of the Company by 6.30 p.m. on 12 June 2023.
